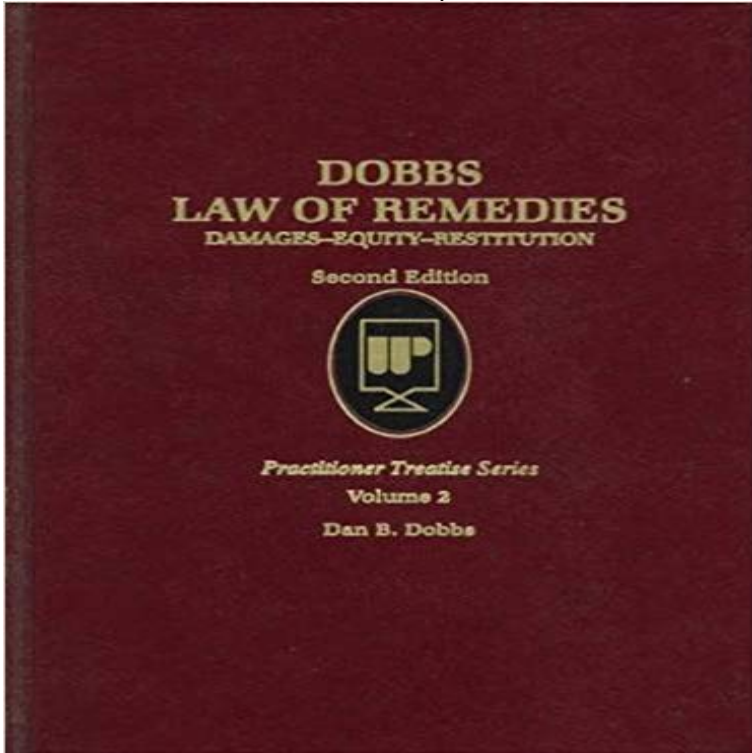


## Law of Remedies V2 (Practitioner Treatise Series)
