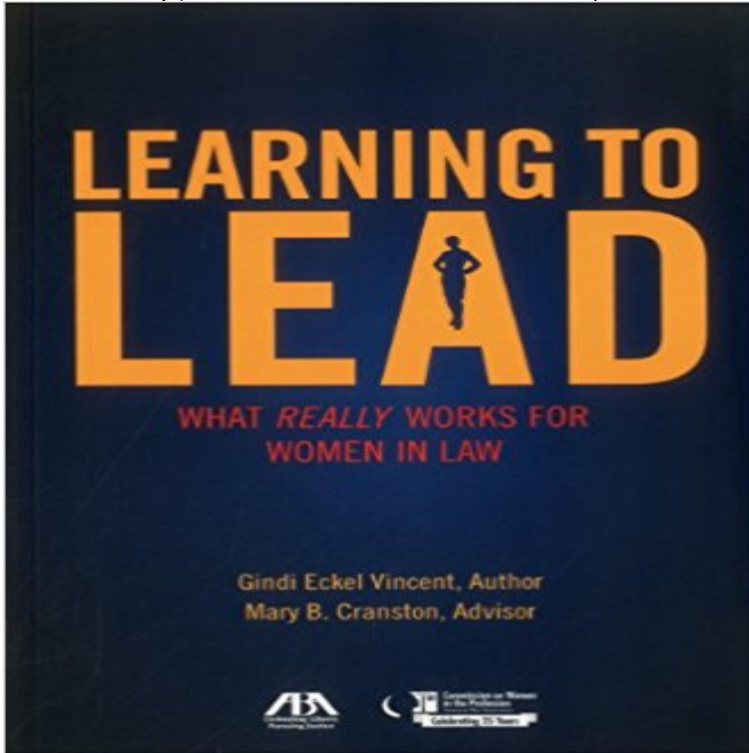


## Learning to Lead: What Really Works for Women in Law
