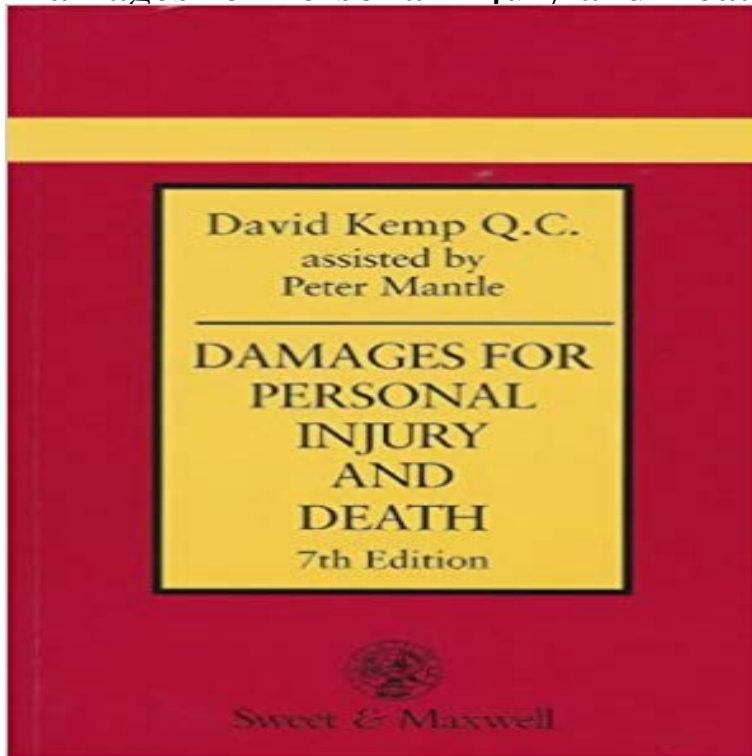


Damages for Personal Injury and Death (Practitioner Series)
