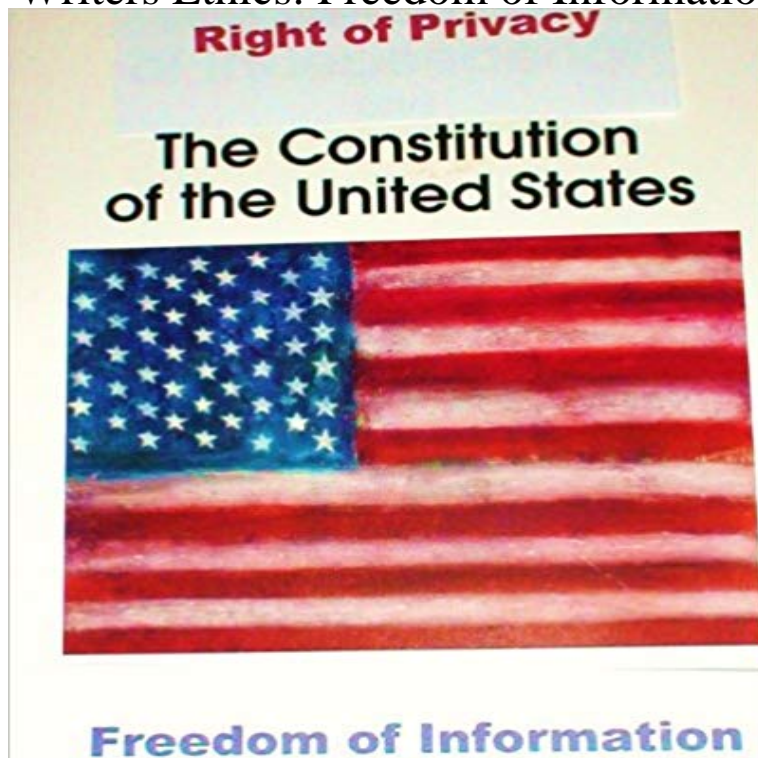


Writers Ethics: Freedom of Information and the Right of Privacy



Writers have used the Freedom of Information Act since its inception to obtain all kinds of information for their stories and books. However, the right to obtain information under this Act is superceded by the need for national security and, more importantly, the right of privacy afforded to private citizens. It is important for all writers and members of the press to know what is allowed and not allowed under the Freedom of Information Act and right to privacy laws so that they dont end up in court, being charged with violations of these laws.
