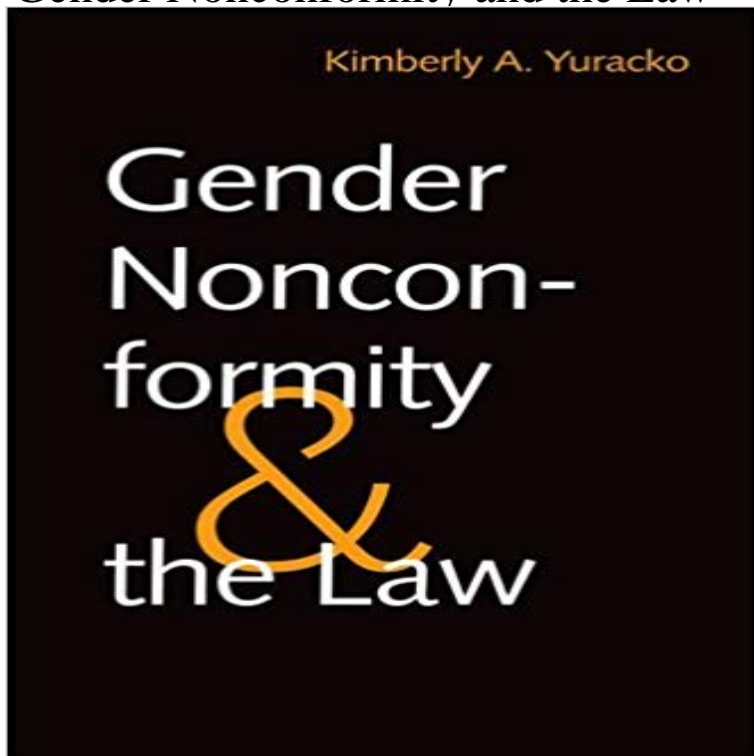


Gender Nonconformity and the Law
