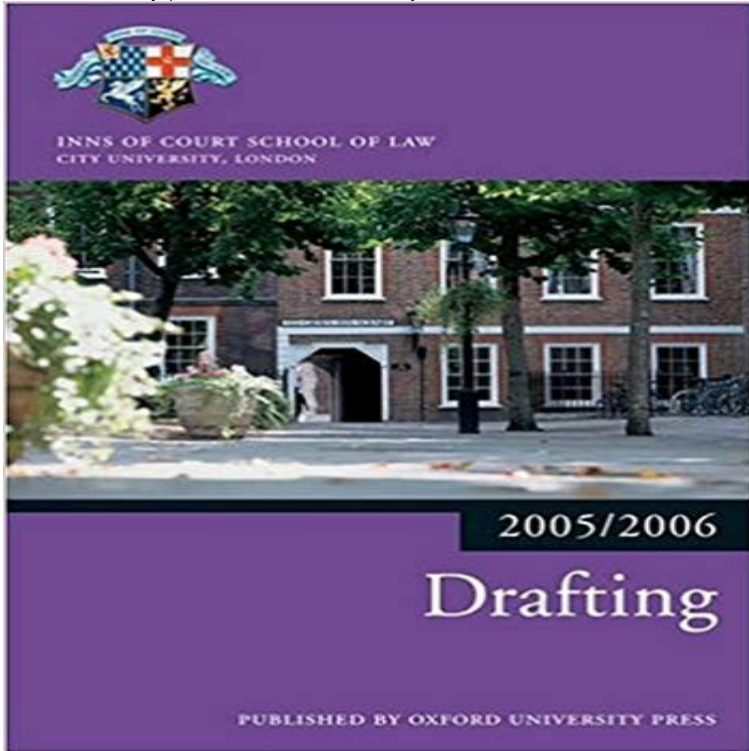


## Drafting 2005/2006 (Blackstone Bar Manual)
