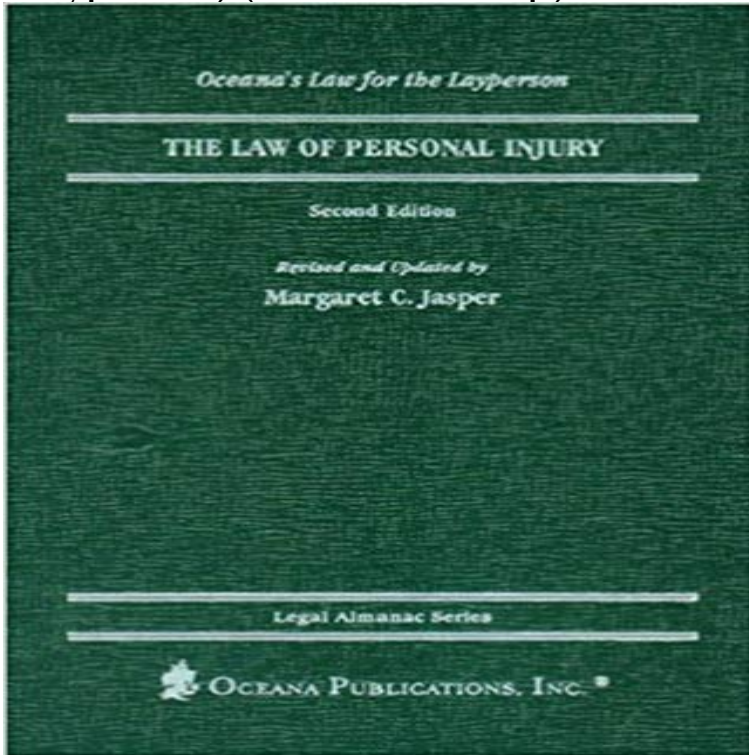


The Law of Personal Injury (Legal Almanac Series. Law for the Layperson) (Revised & Exp)
