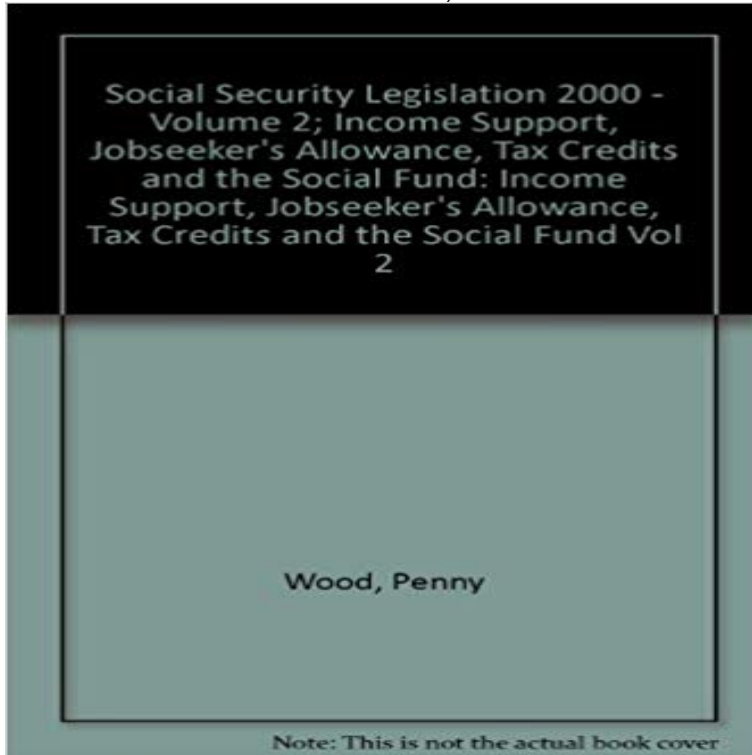


## Social Security Tribunals: the Legislation 2000: Income Support, Jobseekers Allowance, Tax Credits and the Social Fund Vol 2
