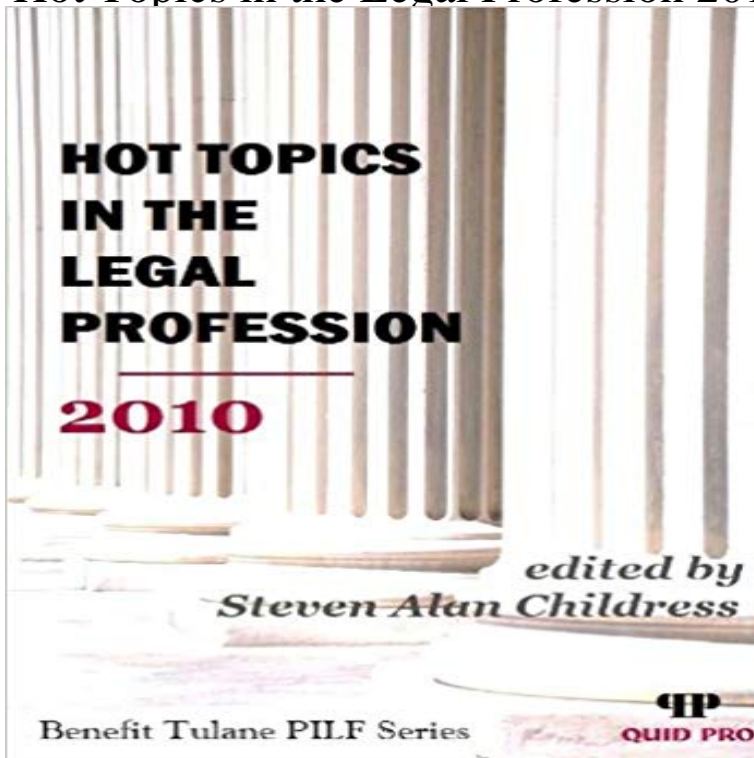


Hot Topics in the Legal Profession 2010 (Benefit Tulane PILF Series)

The collection is edited by Tulane legal ethics professor Steven Alan Childress, and he surveys the big stories of 2009-2010 in his Foreword.
