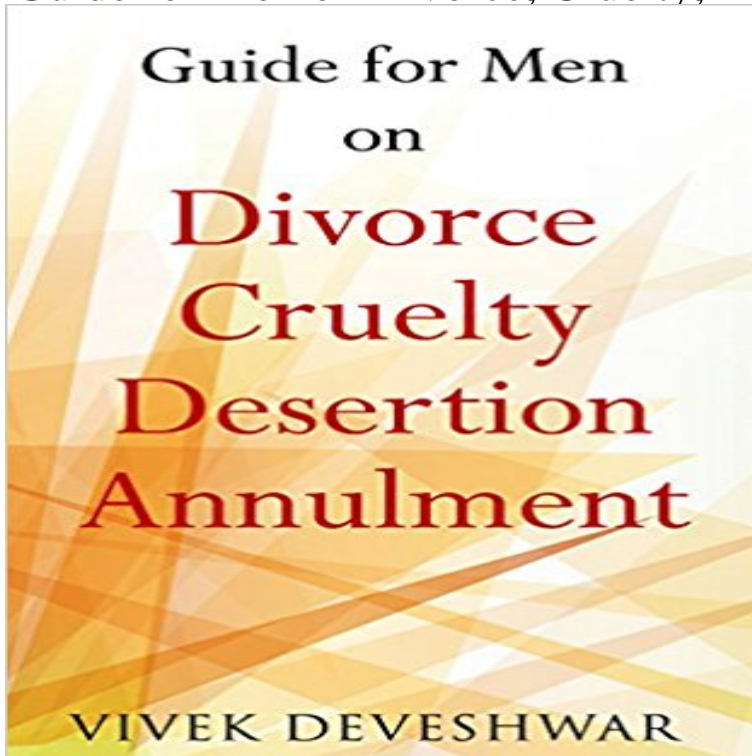


Guide for Men on Divorce, Cruelty, Desertion, Annulment

1. Introduction and difference between mens rights and personal relief. Why filing divorce is about getting a personal relief and not about mens rights.
2. Common patterns seen in dysfunctional marriages, with reference to various wives archetypes: Shoot-to-Kill, Keeping-Away, Keeping-Frustrated, Living-Hell.
3. Sequence of steps and court procedures during a divorce trial.
4. Preparing oneself. How to write the important points of ones case, drafting the petition etc.
5. Collecting evidence, and what kind of evidence should one collect depending on case of cruelty, or adultery.
6. How to find your lawyer and manage him well so that he works for you. How to communicate, set expectations, and be able to pay reasonable fees.
7. How to use the judgments. Judgments cover both cases which went in favour of husbands and few which did not. Useful judgments where wife had asked for divorce etc are also included. Category of judgments

1. The book contains more than 70 judgments discussed in detail and these are divided into following categories.
2. Judgments where divorce was applied by husband on grounds of wifes cruelty. Judgments where divorce was granted to husband, and also where petition was dismissed.
3. Judgments where divorce was applied by wife on grounds of husbands cruelty and it was granted.
4. Judgments where divorce was applied by husband on grounds of false criminal complaints by wife and it was granted. Also judgments where husbands petition was dismissed.

Judgments where divorce was applied by husband on grounds of unproven allegations of adultery/illicit relations of husband and it was granted. 6. Judgments where divorce was granted to husband due to false allegations made by wife after husband had filed divorce petition. 7. Judgments where divorce was granted to husband due to non-consummation of marriage. 8. Judgments where divorce was applied by husband alleging mental disorder of wife. 9. Judgments where divorce was applied by husband/wife based on desertion. 10. Judgments where divorce was applied by husband alleging adultery by wife and it was granted. Also judgments where husbands petition was dismissed. 11. Judgments where annulment was applied for by husband and it was granted. Also judgments where husbands annulment petition was dismissed. 12. Judgments where annulment was applied for by wife. Finally, other sections from Hindu Marriage Act like judicial separation, Section 23A etc. are discussed.
