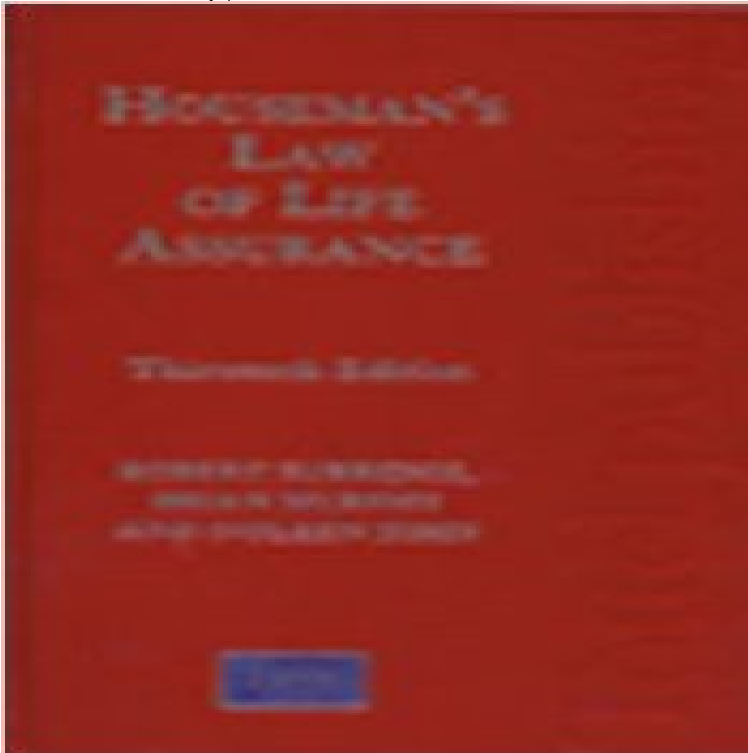


# Human Rights and Criminal Justice
