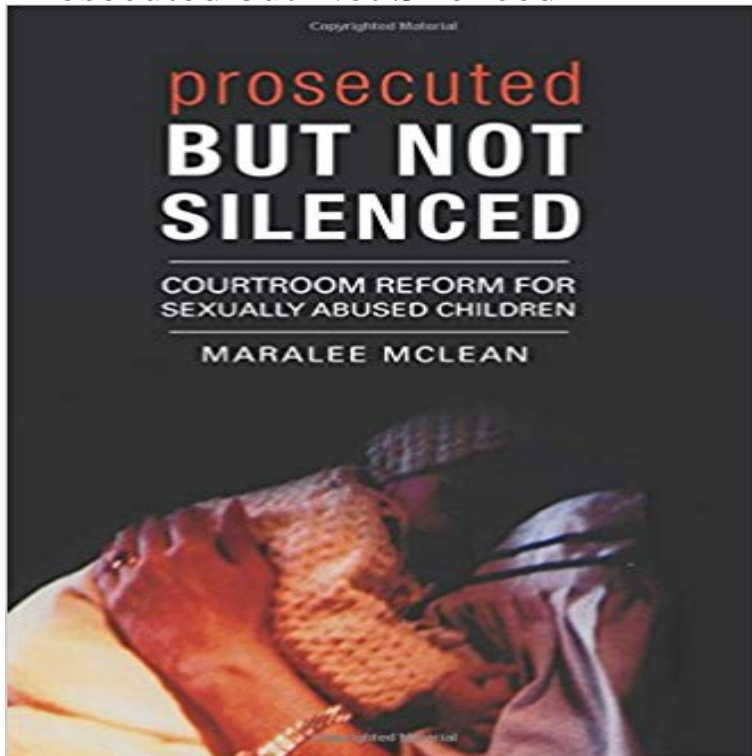


Prosecuted but Not Silenced
