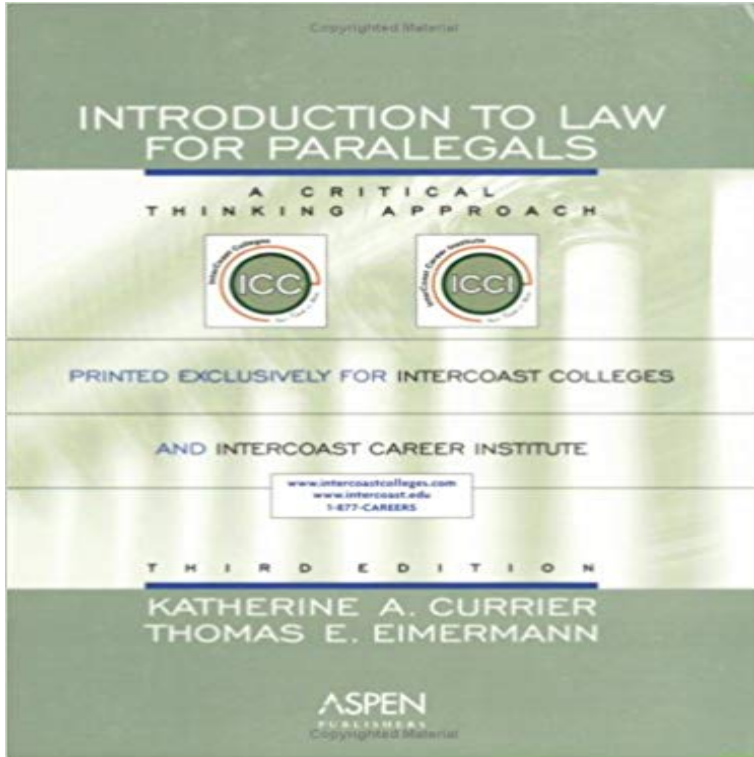


# Intro To Law for Paralegals: A Critical Thinking Approach, Third Edition
