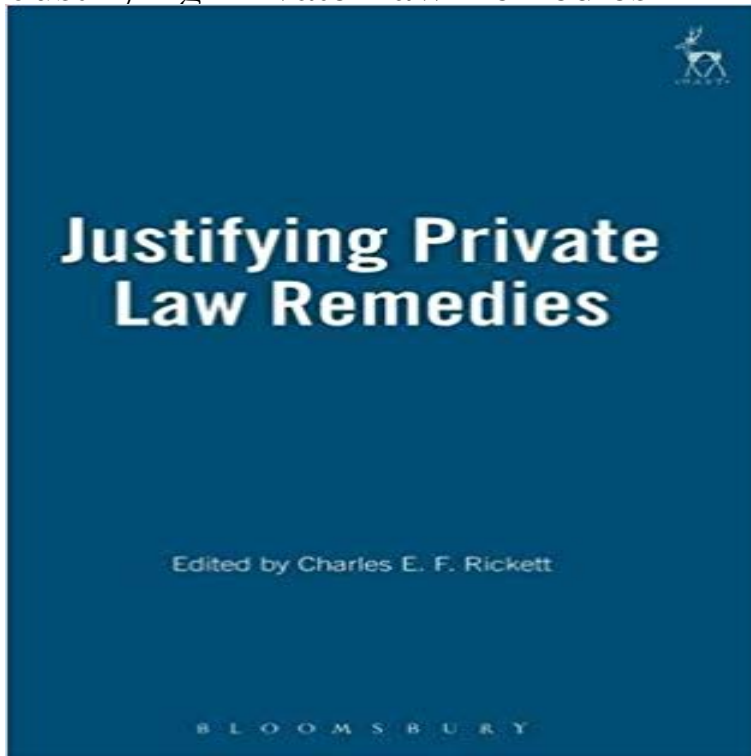


Justifying Private Law Remedies
