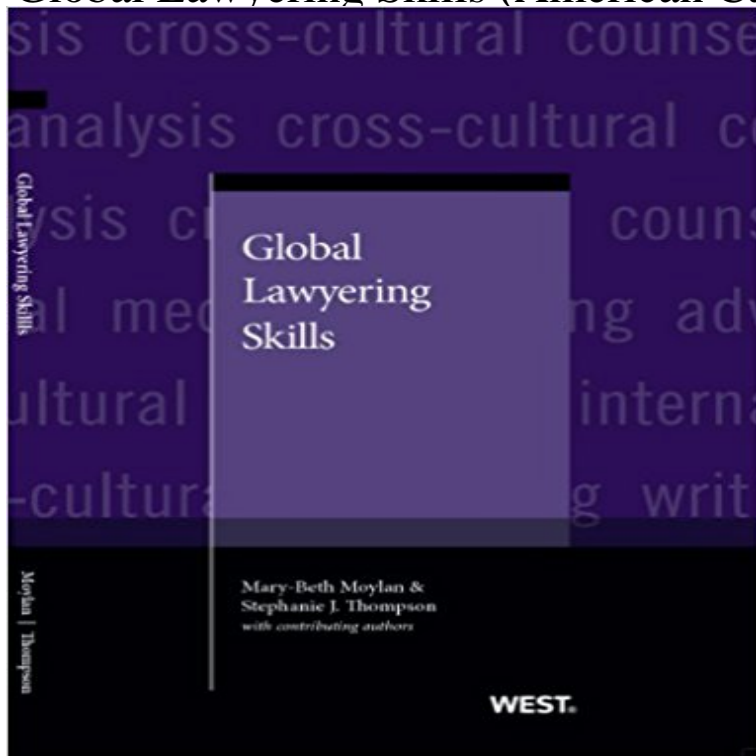


## Global Lawyering Skills (American Casebook Series)

GLS is one of the only legal research and writing textbooks available that covers foreign legal systems, intercultural competence, and cross-cultural considerations in the practice of law. GLS is sufficient for a two-year curriculum, but would also work well in a one, two, or three semester course.
