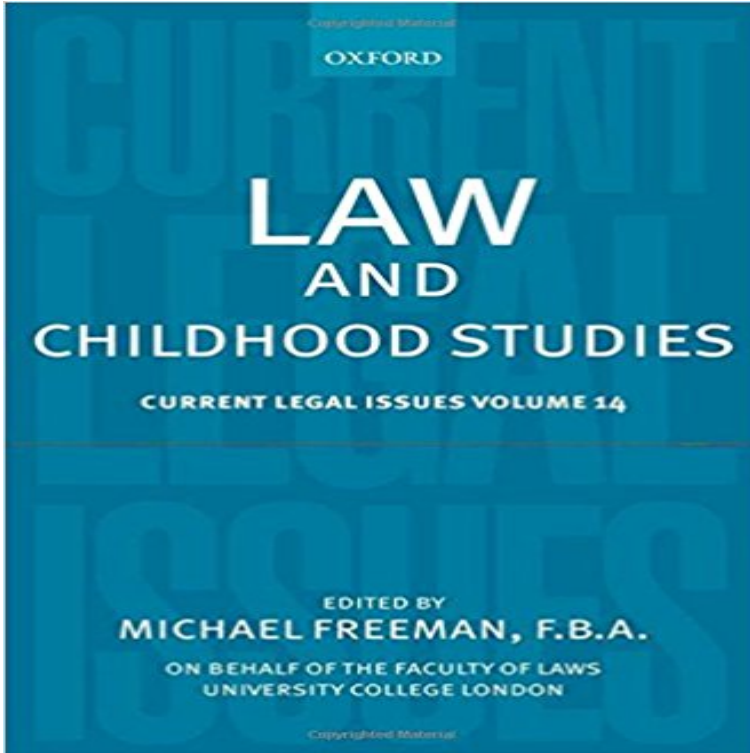


Law and Childhood Studies: Current Legal Issues Volume 14
