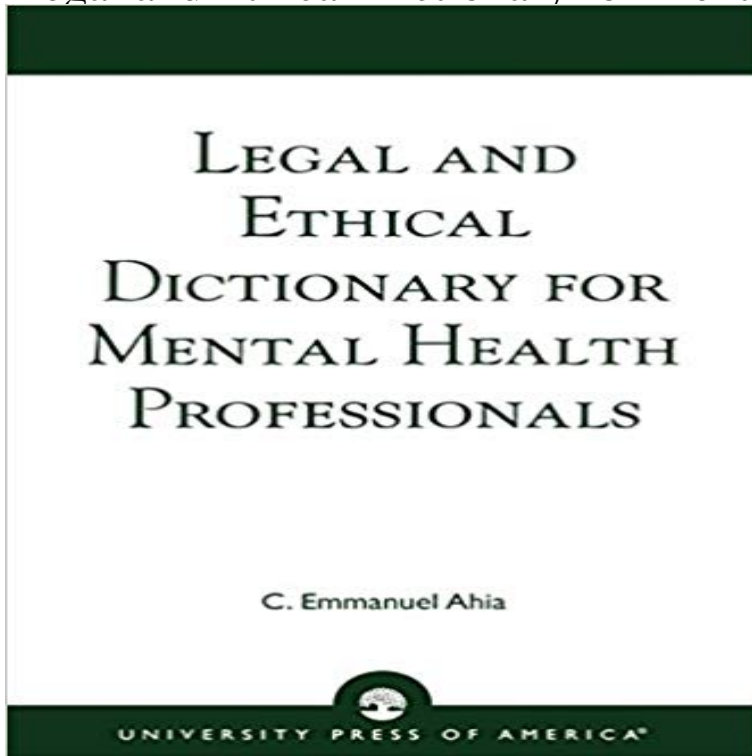


Legal and Ethical Dictionary for Mental Health Professionals
