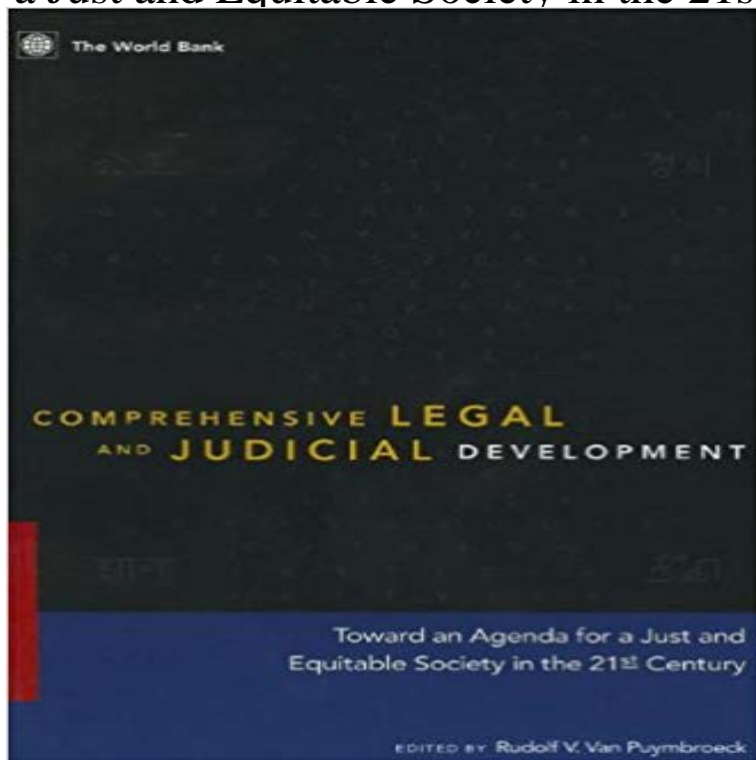


# Comprehensive Legal and Judicial Development: Towards an Agenda for a Just and Equitable Society in the 21st Century
