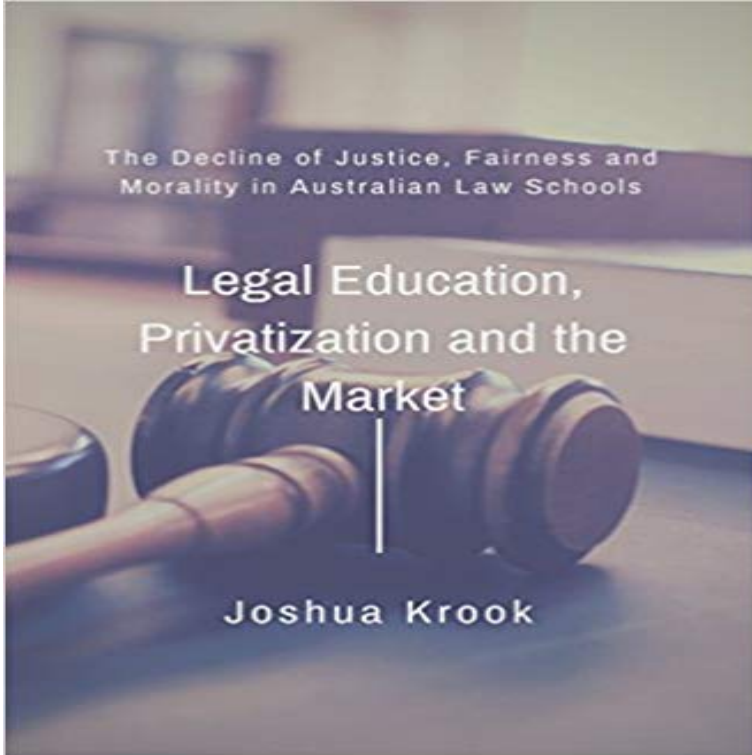


Legal Education, Privatization and the Market: The Decline of Justice, Fairness and Morality in Australian Law Schools
