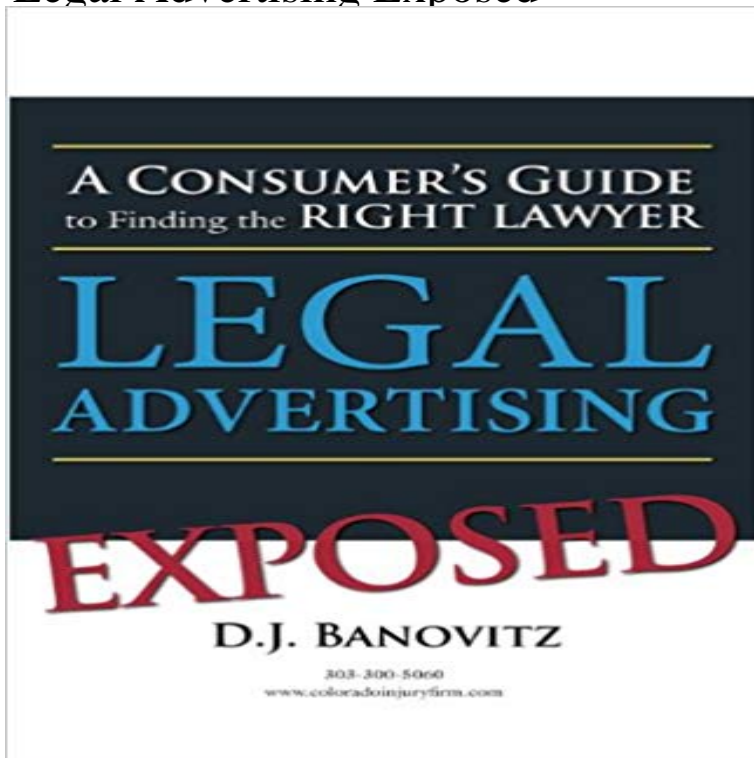


## Legal Advertising Exposed
