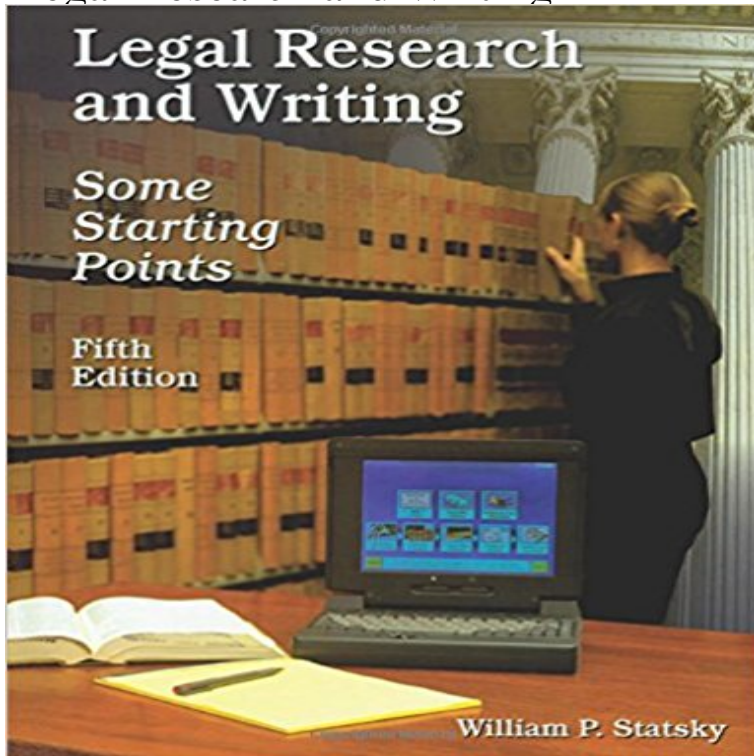


Legal Research and Writing
