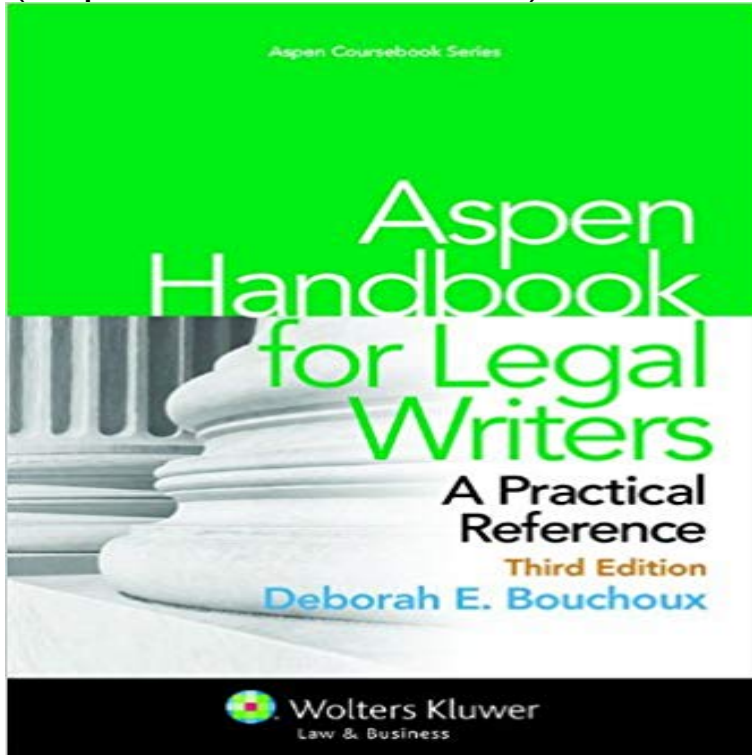


## Aspen Handbook for Legal Writers: A Practical Reference, Third Edition (Aspen Coursebook Series)
