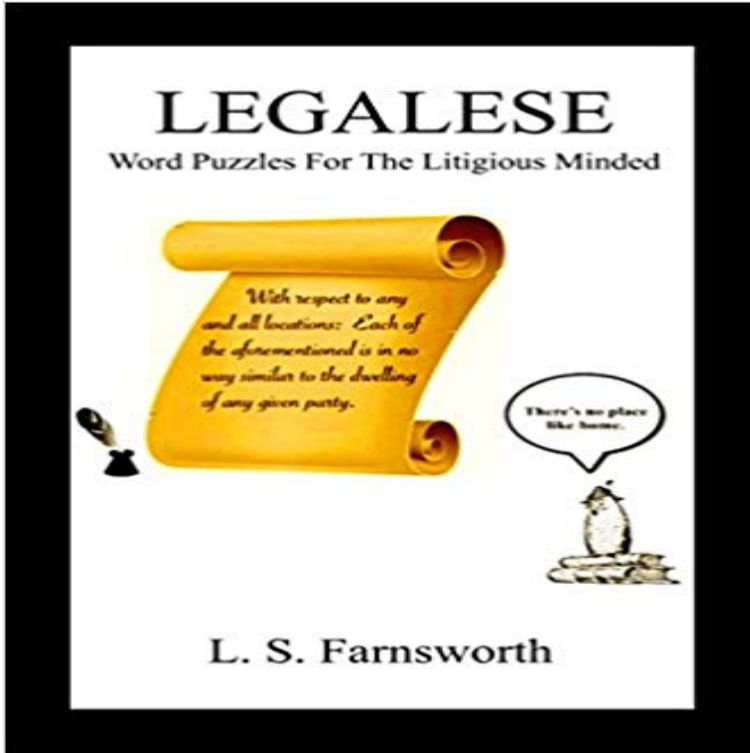


LEGALESE Word Puzzles For The Litigious Minded
