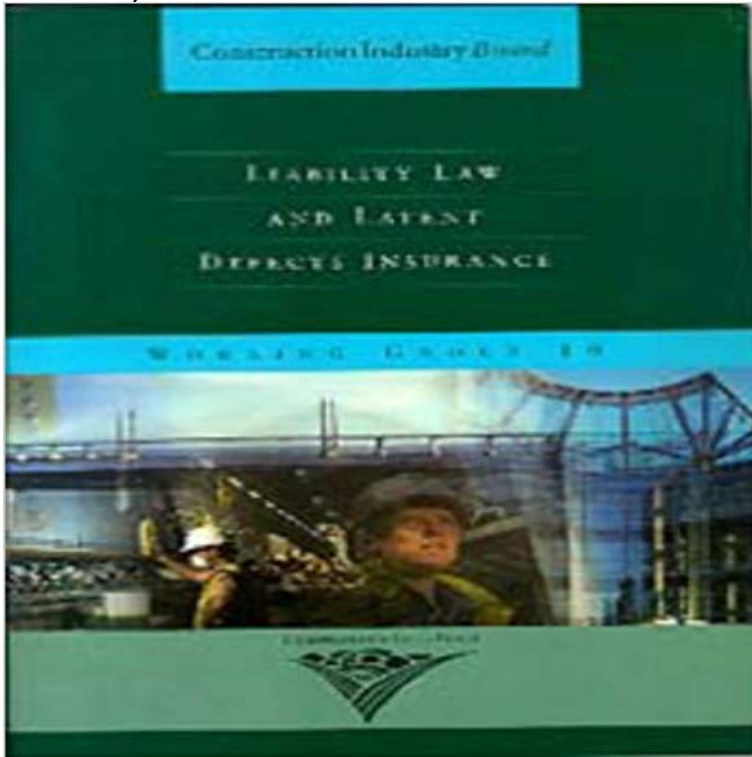


Liability Law and Latent Defects Insurance (Construction Industry Board)
