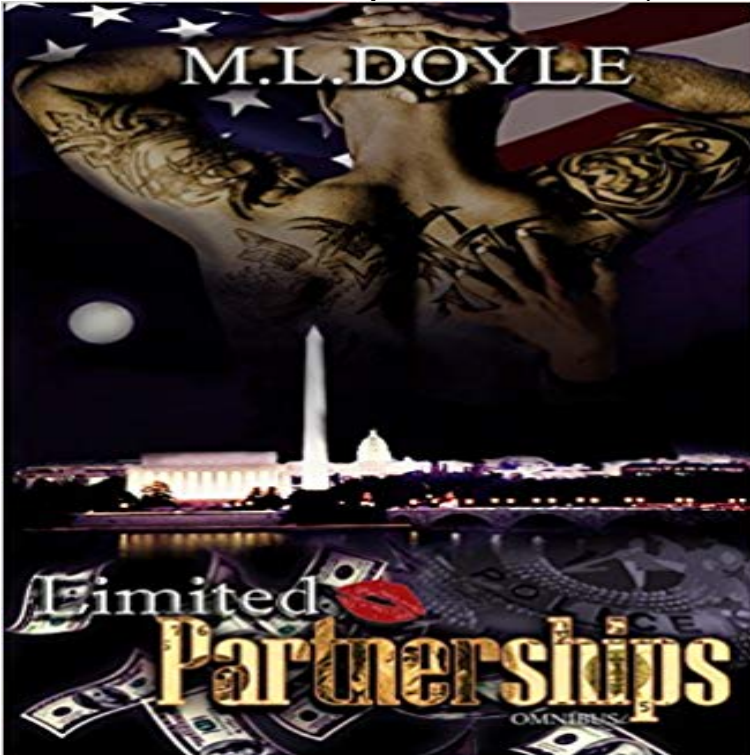


Limited Partnerships - Omnibus (The Limited Partnerships)
