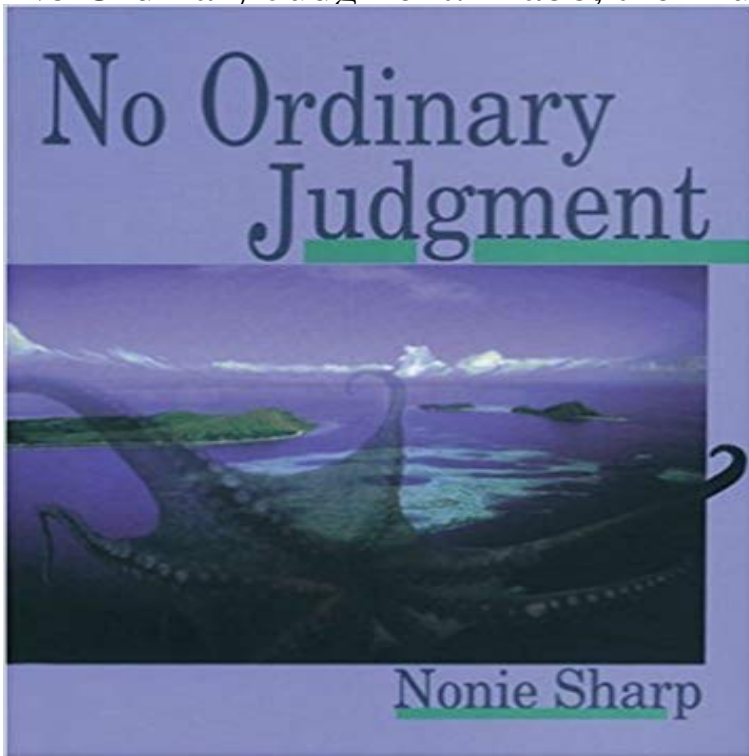


## No Ordinary Judgment: Mabo, the Murray Islanders Land Case
