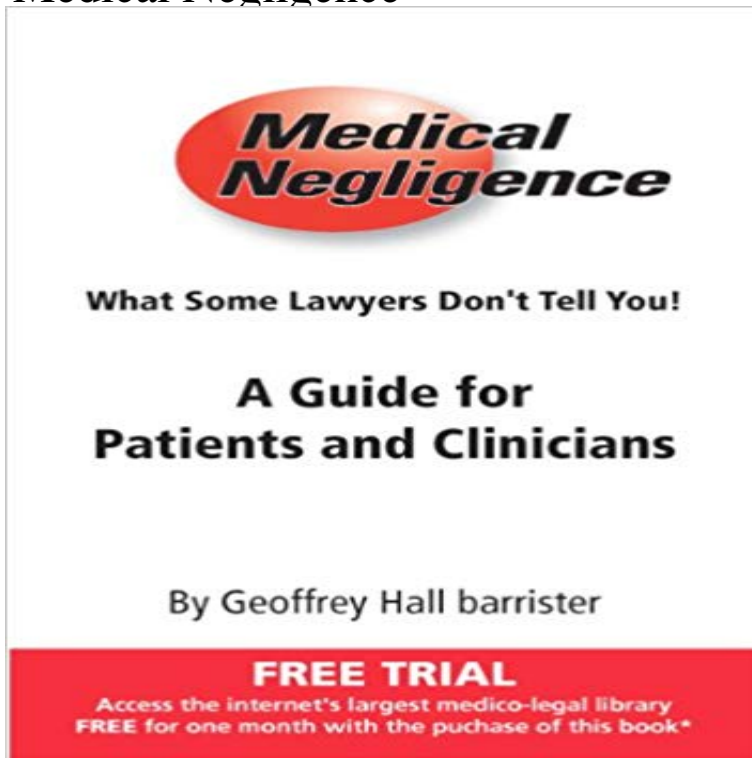


Medical Negligence
