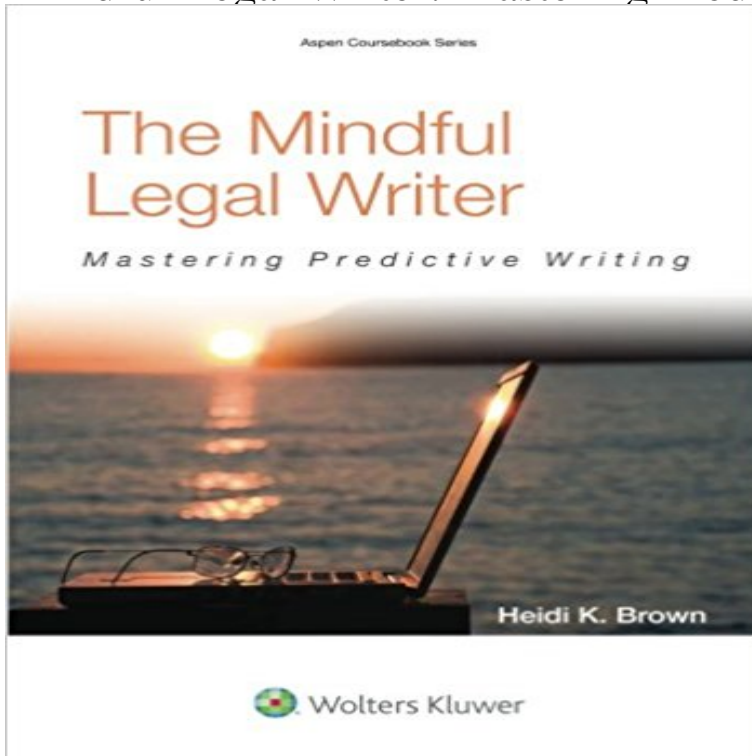


# Mindful Legal Writer: Mastering Predictive Writing (Aspen Coursebook)
