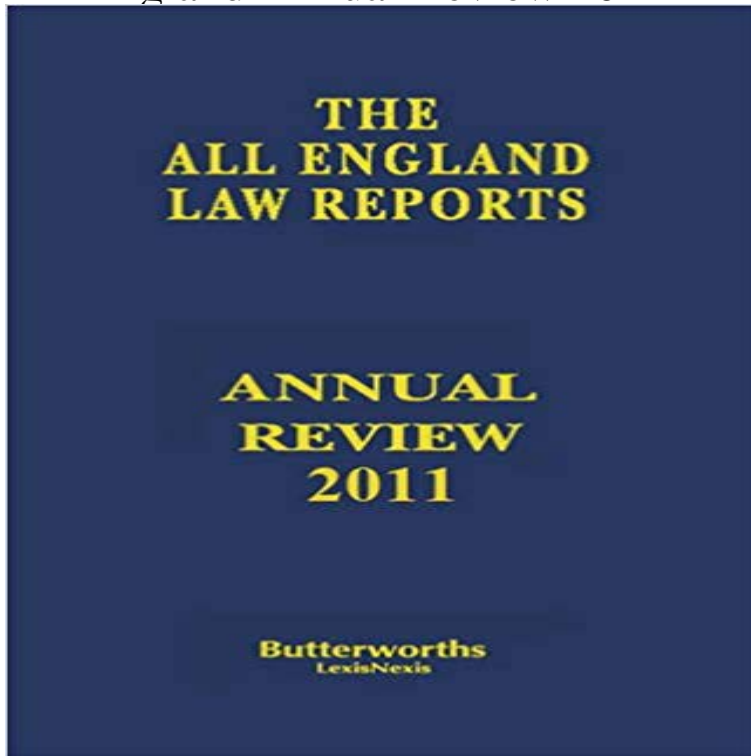


All England Annual Review 2011
