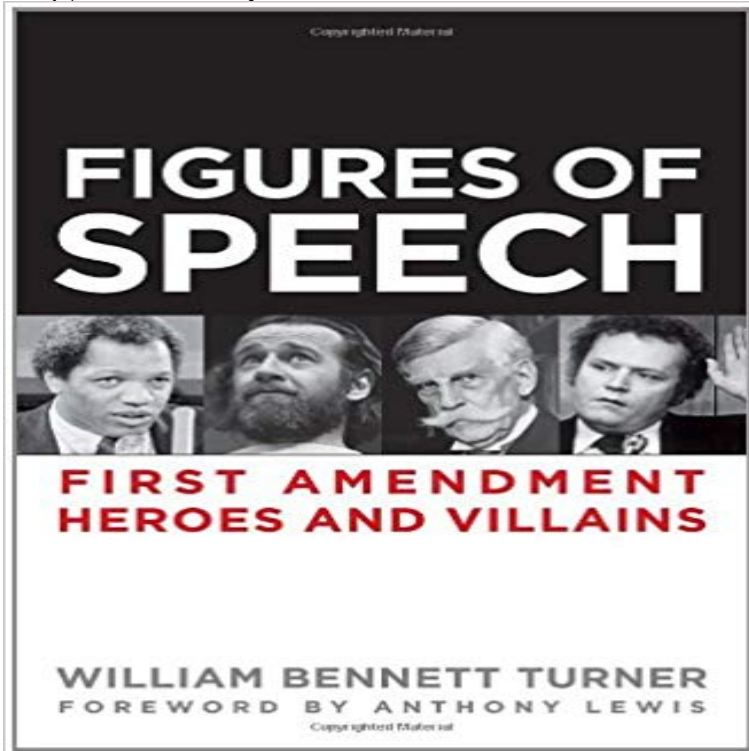


Figures of Speech: First Amendment Heroes and Villains
