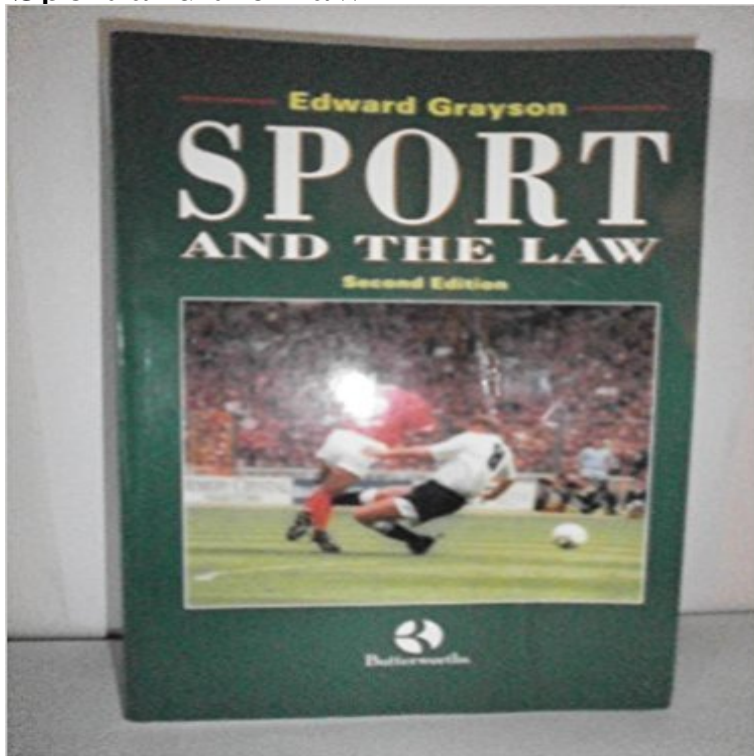


Sport and the Law
