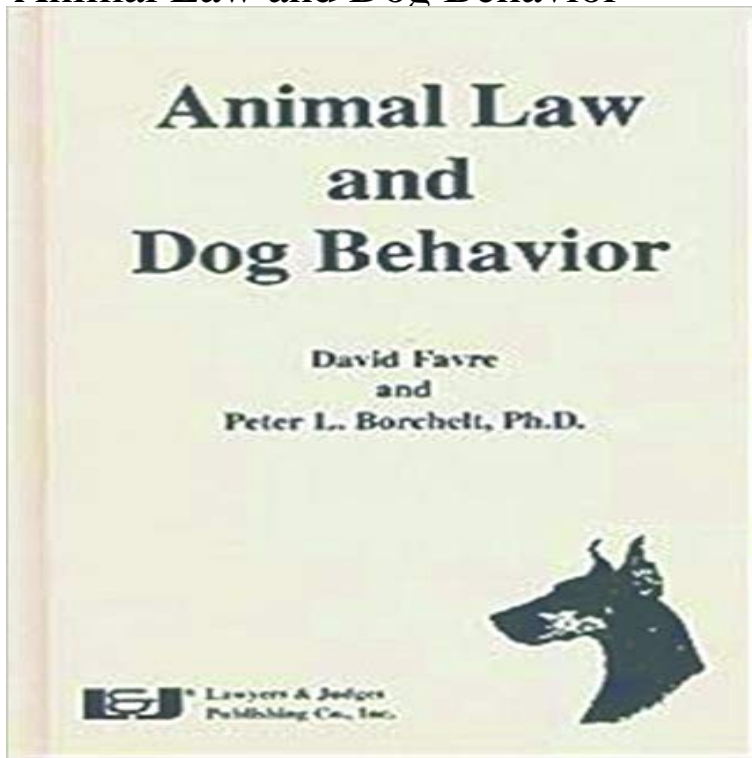


Animal Law and Dog Behavior
