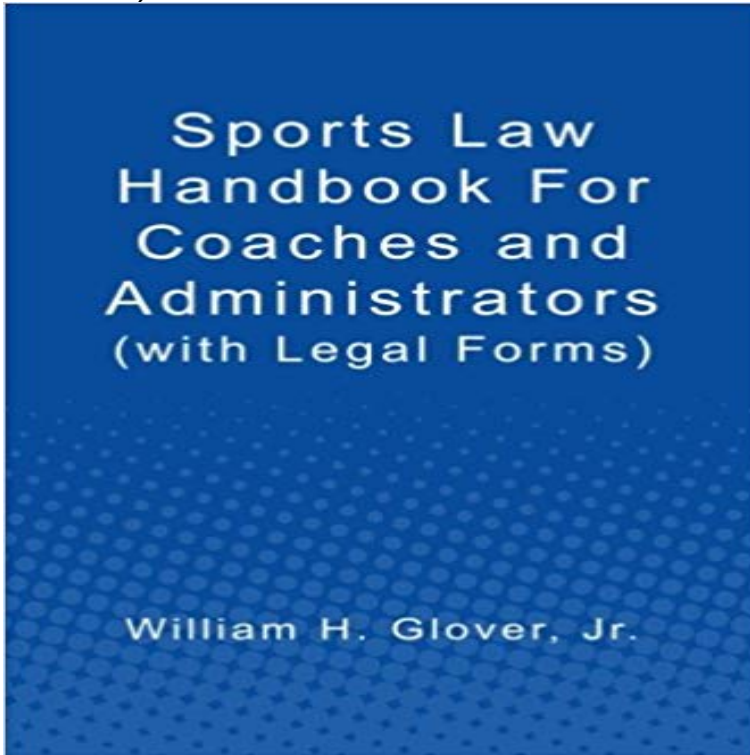


# Sports Law Handbook For Coaches and Administrators: (with Legal Forms)
