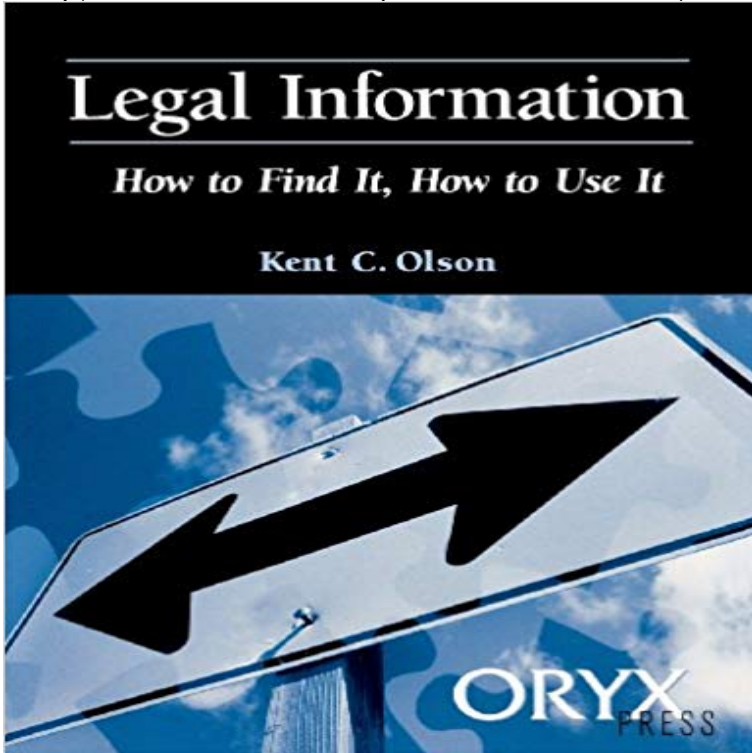


## Legal Information (How to Find It, How to Use It)
