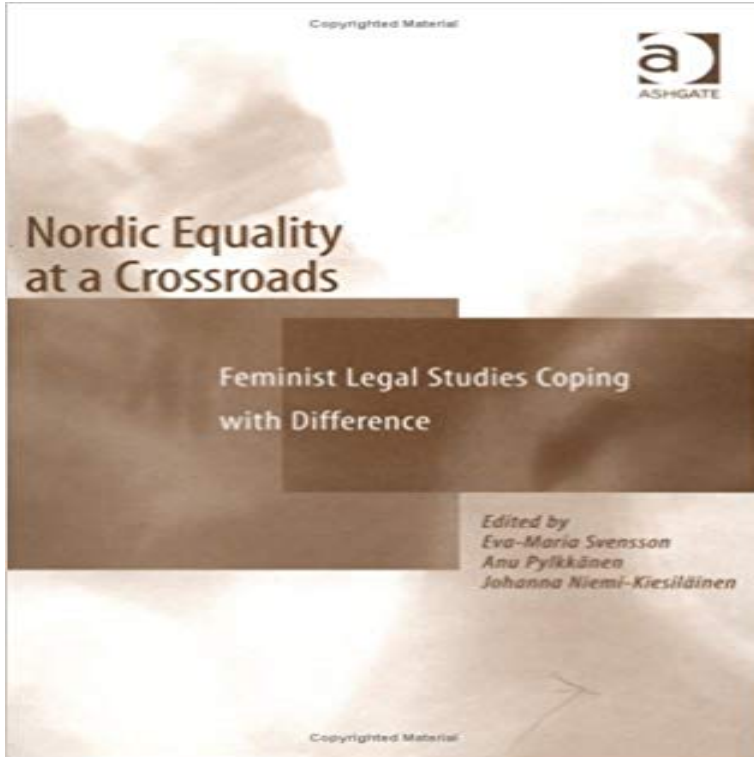


Nordic Equality At A Crossroads: Feminist Legal Studies Coping With Difference
