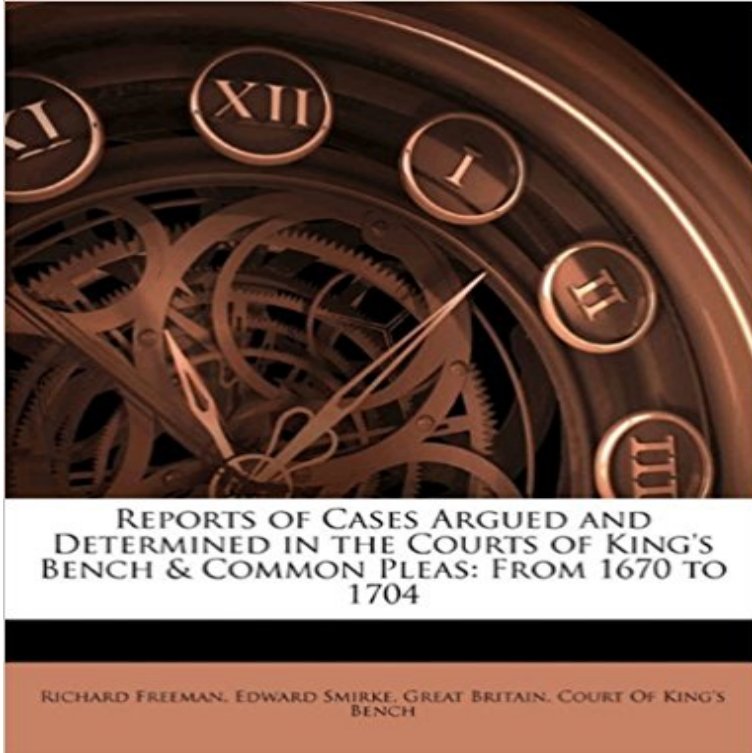


Reports of Cases Argued and Determined in the Courts of Kings Bench & Common Pleas: From 1670 to 1704
