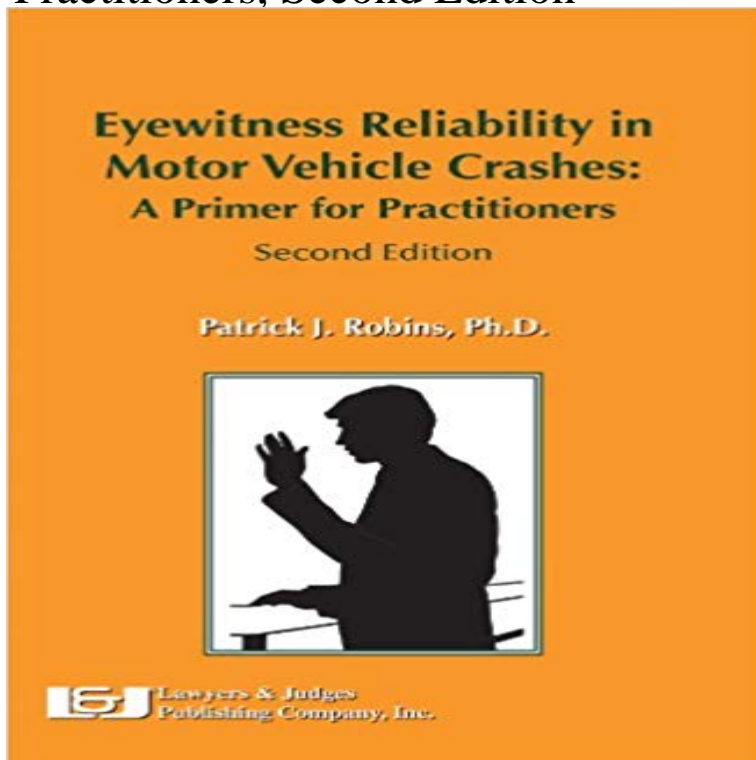


Eyewitness Reliability in Motor Vehicle Crashes: A Primer for Practitioners, Second Edition
