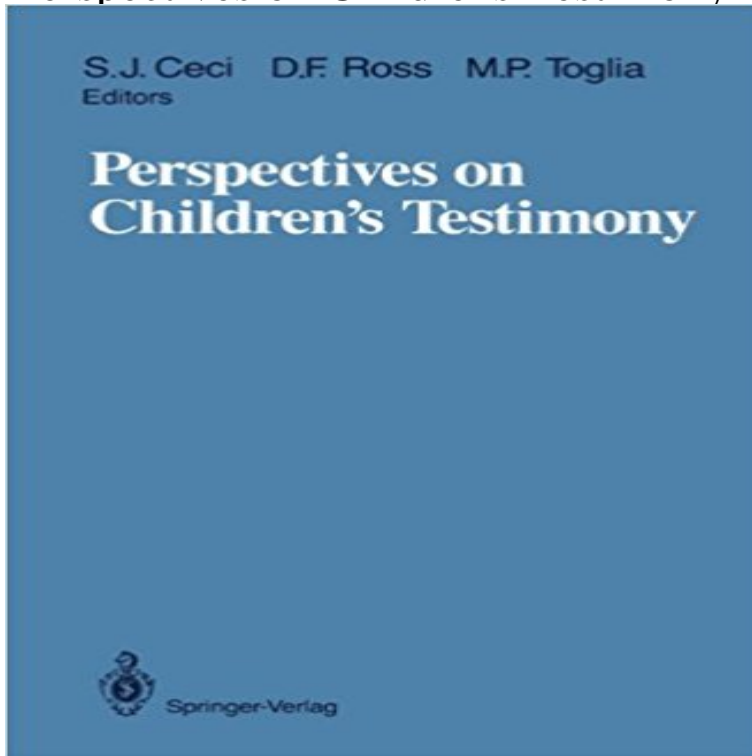


Perspectives on Childrens Testimony

A variety of new techniques are employed in assessing adult views of child witnesses. Special features of the volume include: an in-depth treatment of techniques of interviewing child victims of sexual abuse, an examination of childrens perceptions and knowledge of the legal system, and critical and theoretical integrations of the original, empirical papers.
