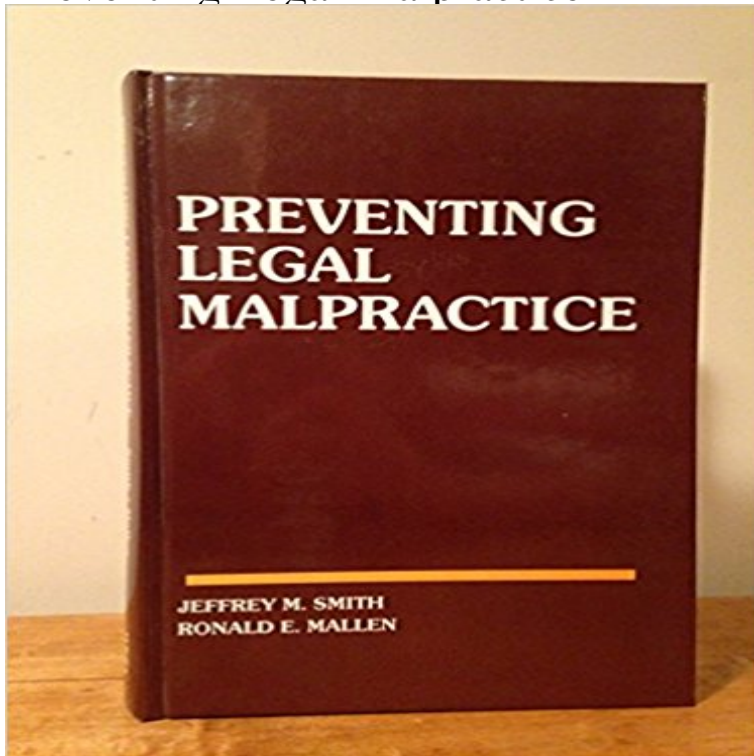


Preventing Legal Malpractice
