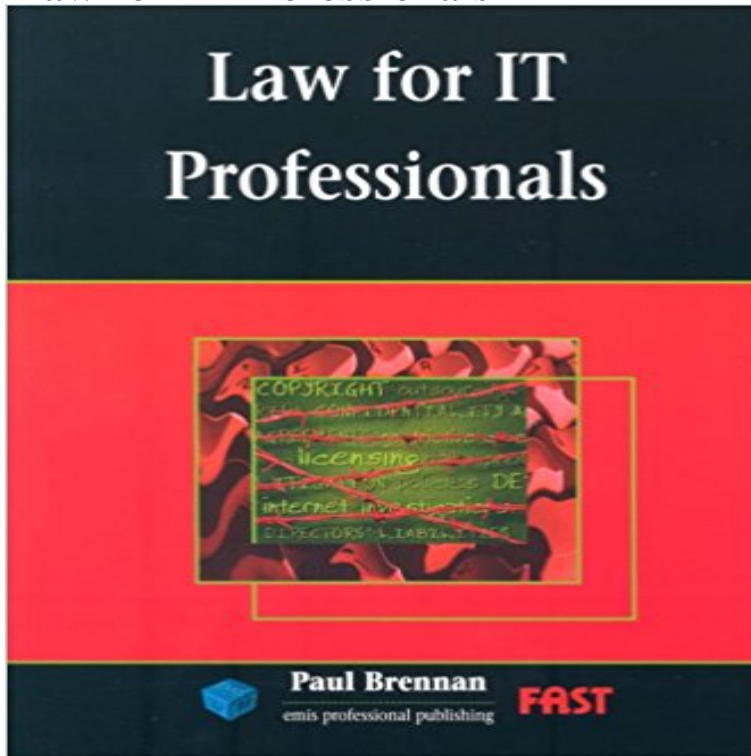


Law for IT Professionals
