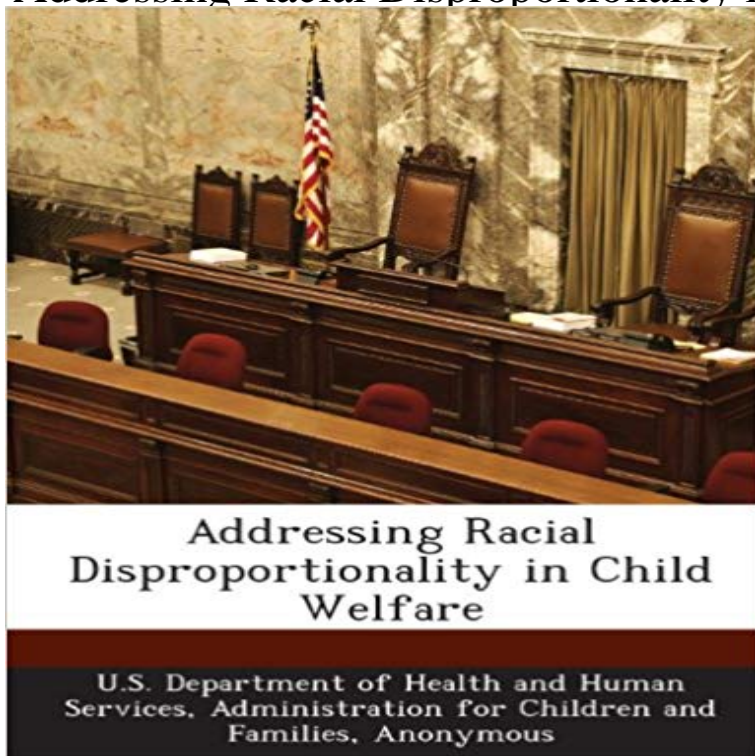


Addressing Racial Disproportionality in Child Welfare
