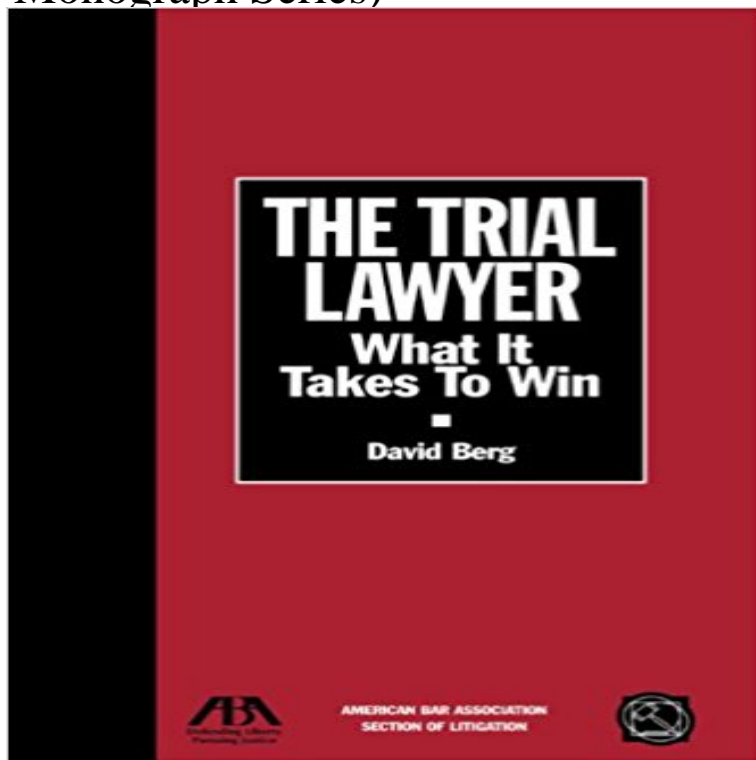


The Trial Lawyer: What It Takes to Win (Section of Litigations Monograph Series)
