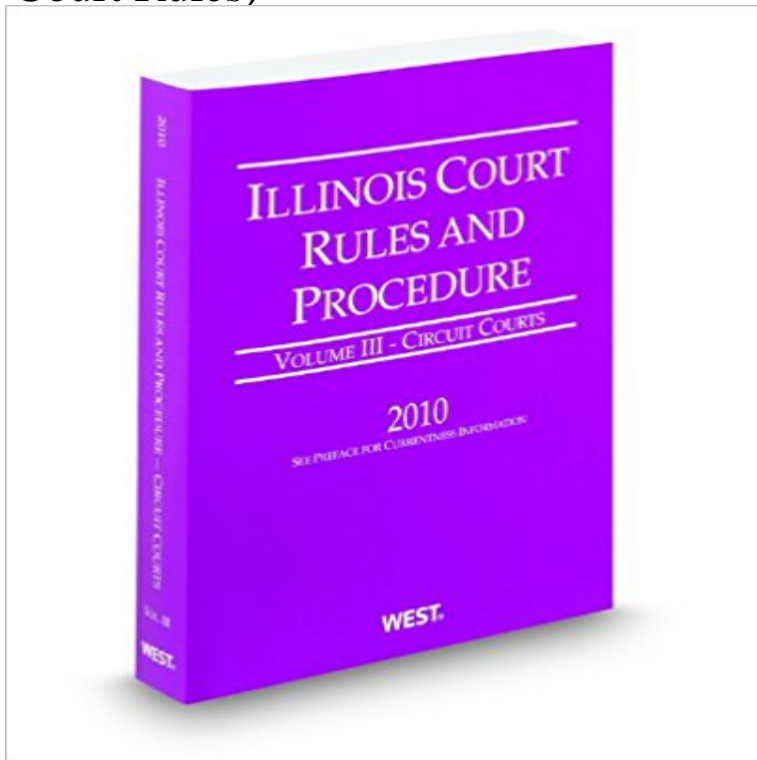


Illinois Court Rules and Procedure - Circuit, 2010 ed. (Vol. III, Illinois Court Rules)
