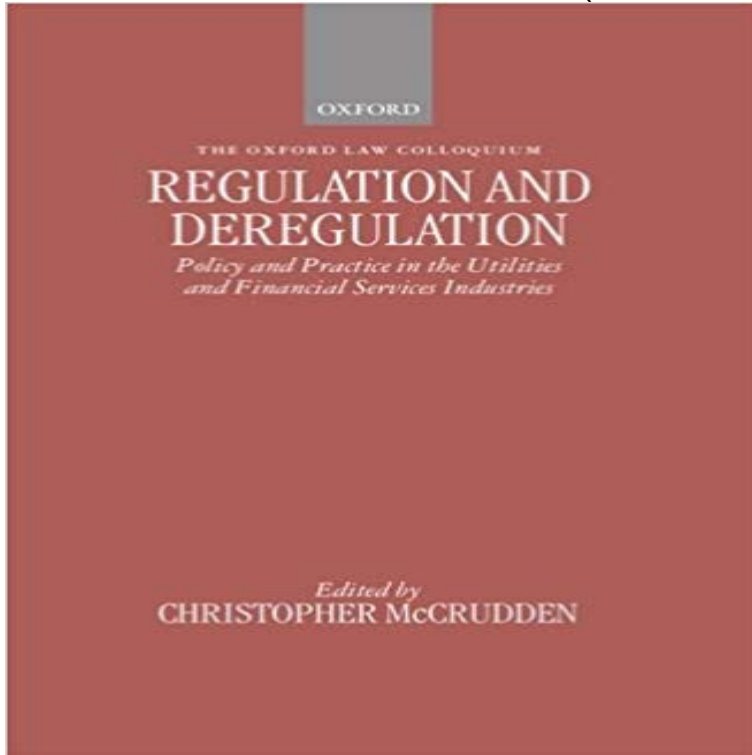


Regulation and Deregulation: Policy and Practice in the Utilities and Financial Services Industries (Oxford Law Colloquium)
