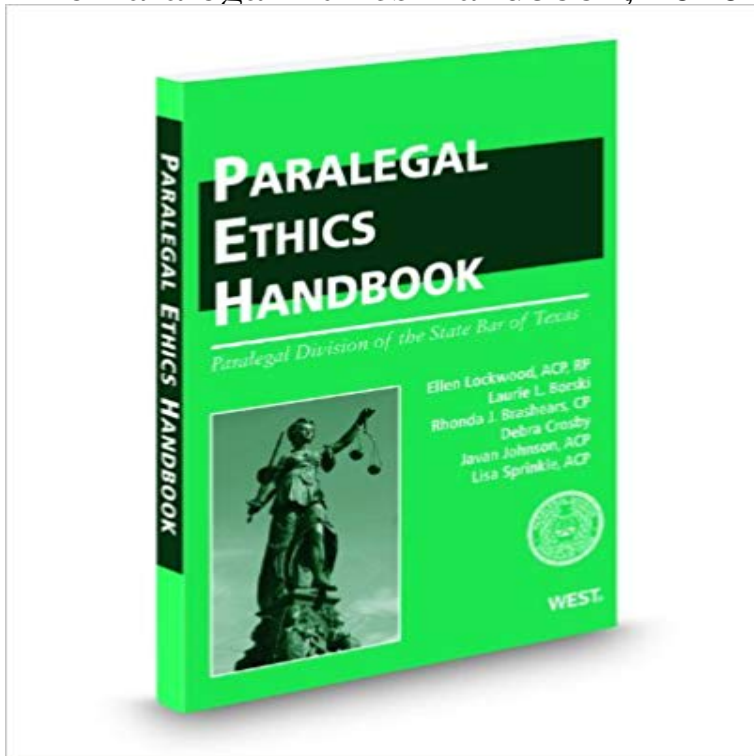


## The Paralegal Ethics Handbook, 2010 ed.
