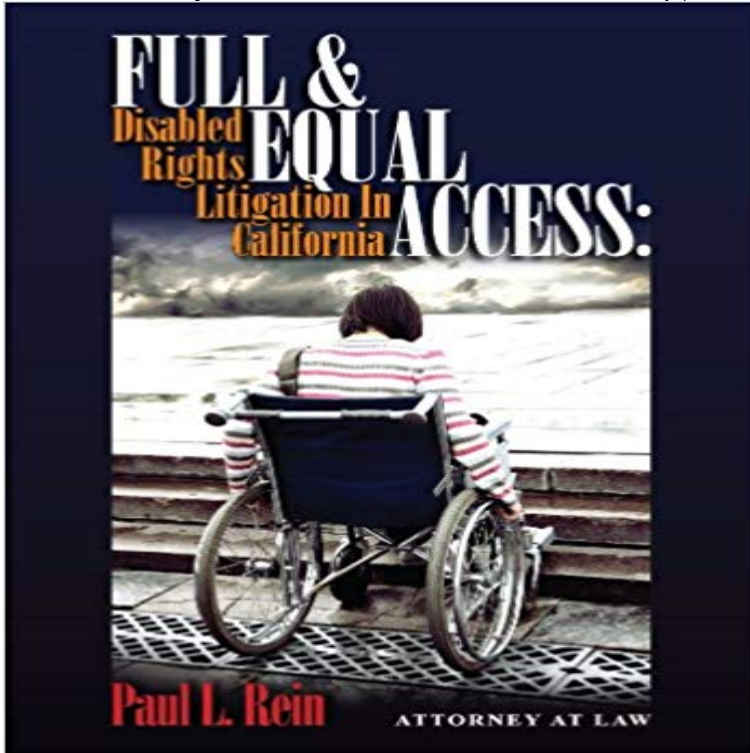


## Full & Equal Access: Disabled Rights Litigation In California



This book is intended to give a general outline of the law regarding access to public accommodations for disabled persons under California laws first passed in 1968. This book will also address aspects of the ADA which may be applied to governmental buildings and facilities or privately owned public accommodations in California, under ADA Title II and Title III. This is particularly necessary as California law has now incorporated any violation of the ADA as a per se violation of California's disability rights laws, including Civil Code sections 51(f), 54(c), and 54.1(d). Although the ADA, Title III, does not have its own damages remedy, an ADA violation may trigger the damages remedies of Civil Code sections 52 and 54.3 under state law, due to incorporation by sections 51(f), 54(c) and 54.1(d) of any violation of the ADA. This adds the potential of a damages award to the other enforcement mechanisms of the ADA. We will also share some tools and techniques to assist attorneys and advocates in obtaining disabled accessible public accommodations. While I also invite defense counsel to read and benefit from the book, I cannot and do not give defense advice. I have never represented or advised businesses, government entities or defendants involved in disabled access lawsuits, and do not consider myself qualified to give any such advice, which must come from a different perspective. There are many qualified lawyers and access consultants (especially those CASp certified) who can properly advise actual or potential defendants, businesses and government personnel on their legal obligations. Moreover, taking proactive steps to provide proper access before any lawsuit is needed will be a win-win situation both for businesses and for their disabled patrons and potential customers. Some practical suggestions may be of use to defendants as well as plaintiffs, and to

their respective attorneys. To the extent I display a bias towards assisting disabled persons to obtain maximized disabled access, both the United State Congress in adopting the ADA, and the California legislature by its progressive statutes (starting 20 years ahead of the ADA), have expressed similar bias in establishing as public policy the goal of maximizing full and equal access for all disabled persons. This public policy will be discussed throughout this book, and is relevant to interpretations of statutory intent. Portions of the book outline some legal precedents that may be of use to disabled persons - and their attorneys and supporters - when they decide to take action to enforce their rights to full and equal access to public accommodations. Individual private lawsuits are necessary to ensure that state and federal access laws are properly enforced. Each action may also have a ripple effect which will benefit every disabled person who is later able to use the improved facilities, and a further ripple effect if it motivates voluntary access improvements by building owners and/or their tenants.
