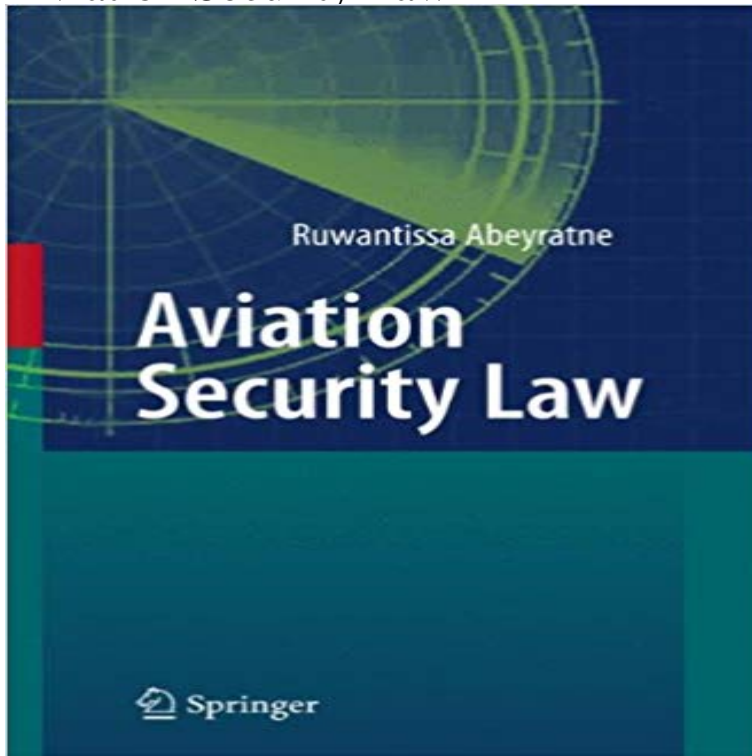


Aviation Security Law
