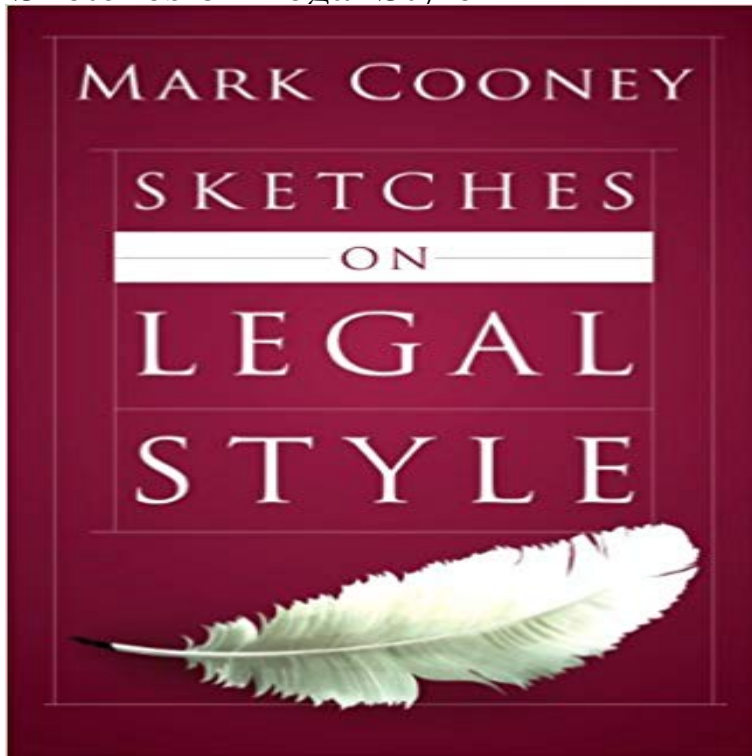


Sketches on Legal Style
