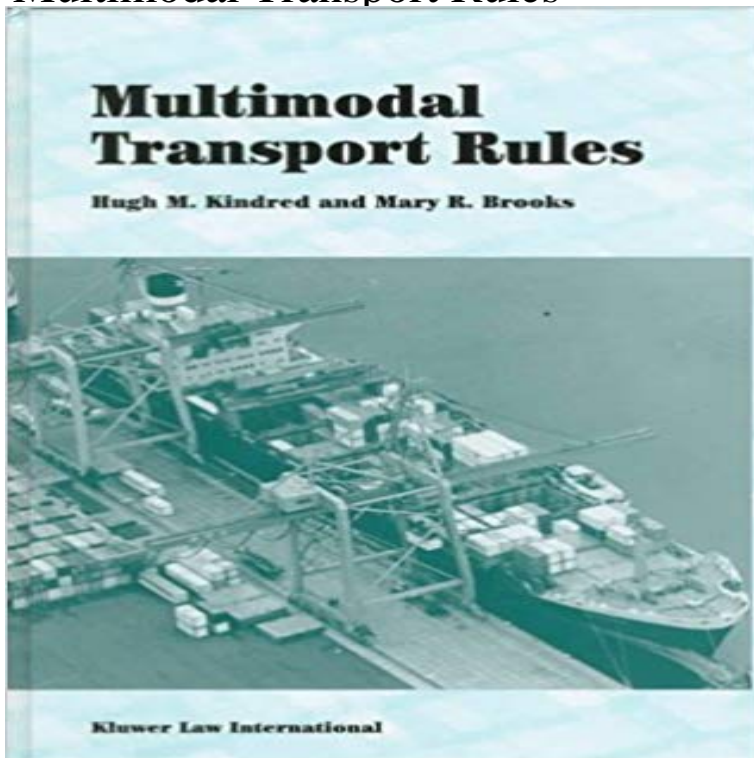


# Multimodal Transport Rules
