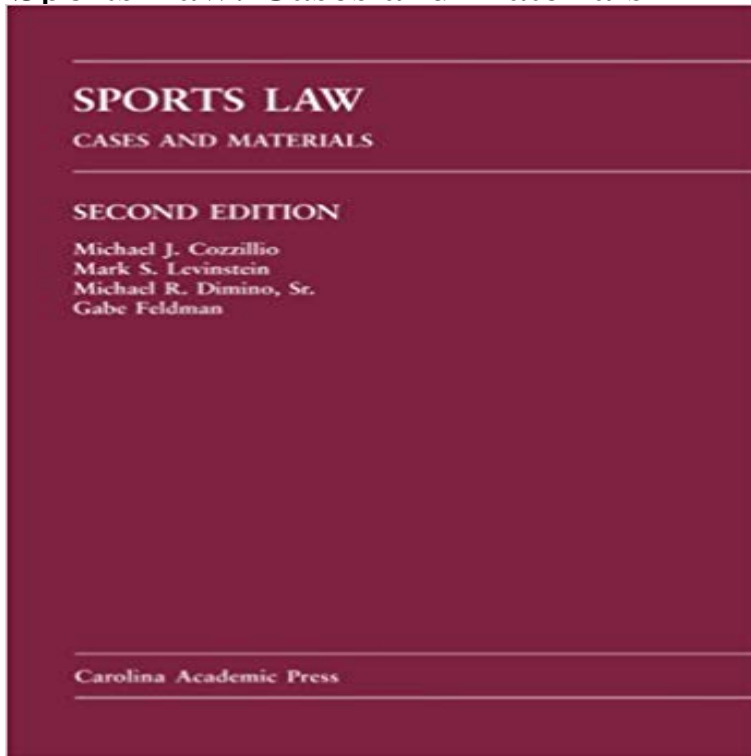


Sports Law: Cases and Materials
